SUBJECT: Election of Board Officers for Calendar Year 2013

I. EXECUTIVE SUMMARY

The Gold Coast Transit Joint Powers Agreement calls for the election of Board officers at or before the annual December Board meeting.

It is recommended that the Board of Directors elect from its members a Chair and Vice Chair to serve for Calendar Year 2013, as stipulated in the GCT Joint Powers Agreement ratified by the Board of Directors in Resolution 2007-04 passed and adopted on June 6, 2007.

II. BACKGROUND

Under Gold Coast Transit's JPA ratified by the Board in June 2007, the Board Chair and Vice Chair are elected for terms of one calendar year running from January 1 through December 31. In prior years under the South Coast Area Transit JPA, Board officer terms ran for the fiscal year from July 1 through June 30. Board officers for Calendar Year 2012 were Chair Bryan MacDonald (City of Oxnard) and Vice-Chair John Zaragoza (County of Ventura).

Following are the names and terms of GCT/SCAT Board officers dating back to 1997-98. Also shown is the distribution of Board officer terms among the five member governments.
